The authorization is consistent with Governor Abbott's Executive Order requiring even essential services to be provided through remote telework from home unless they cannot be provided remotely. The revised authorization added that lawyers and their staff must work from home if possible and provide all services from home unless the services cannot be provided through remote telework. The authorization was also amended to say lawyers and staff may travel to and attend court proceedings, depositions, and meetings with clients and others if

- The Texas Workforce Commission said it will now backdate unemployment claims to the date that workers were laid off, in an apparent revision to its previous position. The agency will date payments for unemployment benefits from the time of the worker's separation of employment. The Houston Federal Courthouse is closed after someone who works there tested positive for COVID-19. The building will reopen to the public **April 10 or April 13**. **Beginning April 2nd**, judges and staff are asked to stay out of the building for a 72-hour period. Harris County Judge Lina Hidalgo signed an order directing the Harris County Jail to release
- "Stay Home, Work Safe" order through April 30, following President Trump's social distancing guidelines. Montgomery County extended their stay-at-home order. The amended order is now in place through April 30, 2020.
- March 30, 2020 The Southern District of Texas entered General Orders implementing the CARES act authorization for video and audio conferencing in criminal proceedings. The orders also allow for
- declaration of a public health emergency. While the order requiring mediation remains in effect, any party may choose to appear at a mediation via technology or telephonically. March 26, 2020 Governor Greg Abbott unveiled an executive order requiring visitors flying to Texas from New York, New Jersey, Connecticut and New Orleans to self-quarantine for 14 days during the coronavirus pandemic. The order aligns Texas with federal guidance that aims to contain the spread of the virus outside New York, which has become the epicenter of the outbreak in the United States. New Orleans, the biggest city in neighboring Louisiana, is seeing its own rise in cases. Starting April 4, 2020, Texas Department of Public Safety troopers will begin manning the state's airports to enforce the executive order. The troopers will screen passengers arriving

- The Supreme Court of Texas issued its eighth emergency order, which delays the statute of limitations in civil cases from March 13, 2020 until June 1, 2020, subject to extension. A previous order had left the issue up to trial courts, a decision that nine bar association and specialized law organization leaders had opposed. The order leaves room for Chief Justice Nathan Hecht to extend the deadline further. • Fort Bend County and Galveston County have extended their stay home orders through the end of April.
- March 31, 2020 Governor Greg Abbott announced an executive order allowing Texans to engage in only essential services until April 30, 2020, to promote social distancing and stop the spread of the coronavirus in Texas. Abbott said all Texas schools will remain closed until at least May 4. The order marks Abbott's most far-reaching restrictions yet to guard against the novel coronavirus. It is not officially a stay-at-home order, and Abbott resisted use of that term, but it has many of the features of such orders and delineates which types of businesses can remain open — including churches, offering the possibility of limited Easter services. Abbott said the order overrides any put in place by local governments that are inconsistent with it, though cities and counties are free to issue stricter provisions in areas not mentioned in the statewide order, if they choose. Governor Abbott released a video on April 1st clarifying that his executive order "requires all Texans to stay at home" except for essential activities. Abbott's order went into effect at

midnight on April 1st. With that, Texas now joins 37 other states that have enacted statewide

March 27, 2020 An emergency standing order was issued for district courts in Dallas County. Under the order, jury trials are suspended until May 8, 2020, or until further order from the County Judge. Cases which have been previously set on the dockets between the effective date of this Order and May 8, 2020 are continued sua sponte and will be reset. Effective immediately, motions may be

determined based upon submission of written pleadings and responses from the parties, without oral argument as shall be determined by each Judge presiding. Any deposition may be noticed to proceed technologically and remotely. The requirement of any court that all parties and

counsel must appear for mediation in person is suspended during the pendency of the Governor's

This declaration is necessary due to the significant disruption to policyholders, carriers, and their staff caused by this disaster, in particular the impact and volume of claims expected to be filed as a result of COVID-19. Taken together, the Governor's suspension and the Commissioner's declaration have the effect of extending claim-handling deadlines imposed by the state's prompt payment laws for an additional 15 days to help carriers respond to the COVID-19 outbreak. - Federal funding was also made available to state and eligible local governments and certain private nonprofit organizations for emergency protective measures. March 24, 2020 • The Texas Supreme Court issued a seventh emergency order stating that existing court orders in child-possession cases shall control "in all instances" to determine rights to and access to children, regardless of so-called shelter-in-place mandates or other restriction on movement by governments during the COVID-19 pandemic. Many of Texas' biggest urban cities and counties have issued "Stay Home, Work Safe" orders as coronavirus spreads, including Houston, Dallas, San Antonio, and Austin. The orders do not completely bar residents from leaving their homes; people are encouraged to go on outdoor walks while keeping a six-foot distance from others, visit grocery stores and pick up medicine. Health care workers and other businesses providing "essential services" will still be working in all the counties issuing the mandatory shelter-in-place orders. Gas stations will also remain open. • With COVID-19 testing and treatment in sharp focus, Texas responded with orders and requests

Historic sites and state parks will reopen at the direction of the Governor. Governor Abbott announced that the Texas Health and Human Services Commission has

adopted an emergency rule to allow end-stage renal disease facilities to treat patients more effectively during the COVID-19 response. This emergency rule provides increased flexibility to providers to serve dialysis patients. This will be helpful in providing appropriate social distancing and/or provide locations for patients that have tested positive for COVID-19 at a location separate from other dialysis patients to reduce the chance of spreading the virus. accounts, which industry groups said could be a death sentence for small businesses, including restaurants. The order does, however, provide electricity providers with millions of dollars in interest-free loans and reimbursements, paid for by ratepayers, which regulators said was

necessary to avert a spate of private utility bankruptcies, which could lead to a major collapse of

President Trump approved Governor Abbott's COVID-19 disaster declaration and federal assistance request for Texas, opening up new sources of funding for individual and public assistance that will help Texas respond to the public health emergency. The President's action makes federal funding available for crisis counseling for affected individuals in all areas in Texas.
